- 3) Income Ceiling (Pre-Matric (Class I-X) [Component-II] Scholarship):
 - a) No income bar for the children of those Engaged in Occupation involving Cleaning and Prone to Health Hazards.
- 4) Children of those Engaged in Occupation involving Cleaning and Prone to Health Hazards, Eligible candidates will submit a certificate from District Social Welfare office, identified officer of Local body, Civic Agency or any such authority as designated by State Government.

For Applicants:

- Applicants are advised to apply online application for the above scholarship schemes on the website of National Scholarship Portal at http://scholarship.gov.in for both Fresh and Renewal.
- 2) Applicants are advised to give only that bank account details which remains in active mode so that payment of Scholarship does not fail as all the disbursement of Scholarship will be made through DBT mode. The authority shall not be responsible for any failure of transaction due to inactive or incorrect bank details.
