Eligibility criteria:

- i) A minimum of 60% aggregate percentage of marks or equivalent grade in (10+2) examination for General Category and 55% aggregate percentage of marks or equivalent grade in (10+2) examination for the SC/ST/OBC/EWS/PWD candidates will be considered as eligibility criterion.
- ii) In the allotment of admission to a Major, preference will be given to candidates having the subject in the (10+2) examination.

Application Procedure:

Admission to the FYIPGP shall be provisioned through the Assam Higher Education Admission Portal (https://assamadmission.samarth.ac.in) after declaration of 10+2 result conducted by the Assam Higher Secondary Education Council (AHSEC). For details, candidates are advised to visit the aforementioned website and Dibrugarh University website frequently.

Selection Procedure

Please refer the Admission Modalities for admission to the Five-Year Integrated Post Graduate Programme of Dibrugarh University, 2024-2025 session.

- a) 50% of the total seats in each Department/Centre of Studies of Dibrugarh University shall be filled up based on the performance of the candidates in the Common University Entrance Test for Under Graduate programmes (CUET-UG 2024) in the relevant discipline conducted by National Testing Agency (NTA).
- b) Remaining 50% of the seats in each Department/Centre of Studies of Dibrugarh University shall be filled up on merit basis, based on the aggregate percentage of marks secured by the candidates in the (10+2) examination conducted by the recognized boards.
- c) Statutory Reservation Policy shall be followed as per the Government Rules by the University while preparing the Merit List of the candidates.

Admission Schedule:

- a) Admission to all the Departments/Centres of Studies shall be held separately. The Schedule and Procedure for admission shall be notified on the website: www.dibru.ac.in along with the List of the Provisionally Selected Candidates prepared by the Admission Committee of the Department/Centre of Studies.
- b) The admission and other fees to be paid at the time of admission shall be received through online payment system. The University shall guide the candidates for payment of their fees.
