TERMS & CONDITIONS.

1. The candidate must be an Indian citizen as defined in Article 5 to 8 of the Constitution of India.
2. The candidate must be **a graduate from any discipline for the post of Office Assistant and for the post of Peon, candidate must be Class-VIII passed but below Higher Secondary.**

The candidate for the **post of Office Assistant** should have Basic word processing skills and the ability to operate computer and skills to feed data, Good Typing Speed with proper setting of petition, Ability to take dictation and prepare files for presentation in the Courts, File maintenance and processing knowledge.
5. A candidate shall not be less than 18 years and upper age limit is 38 years in case of general category, 41 year in case of OBC and 43 years in case of SC/ST candidates as on 31st May 2024.
