The creation of posts shall be subject to fulfillment of the following conditions:

- i. The Appointing Authority of the newly created posts in the districts under Karbi Anglong Autonomous Council and North Cachar Hills Autonomous Council shall be the Principal Secretary of the respective Autonomous District Councils as per Finance Department's OM No. FSI.7/2021/7 dated 20th March, 2015.
- ii. The Appointing Authority of the newly created posts of BTR Area shall be the Bodoland Territorial Council as per Para 5.4 of "Memorandum of Settlement with BLT, 2003".
- iii. The Pay Scale of the newly created post of Secretary shall be Rs.14,000-60,500 + GP. Rs.7400/- as per the Assam Service (Revision of Pay) Rules, 2017. The expenditure towards salary shall be borne from Devolution Grant of State Finance Commission as per endorsement of Finance (Economic Affairs) Department vide ECAB/P&RD/2023/7.
