#### **TERMS AND CONDITIONS OF RE-ENGAGEMENT OF RETIRED STAFF:-**

1. The scheme is valid upto **30.06.2025**.

2. Staff retired from Railway Service from the corresponding cadre can only apply.

3. The re-engagement shall be strictly upto the age of 65 years (OR) till 30.06.2025 (OR) till the availability of regular candidates, whichever is earlier. Senior-most retired re-engaged employees in terms of age will be disengaged first on joining of regular candidates.

4. The maximum upper age limit for the Re-engagement of retired staff is 65 years. The service of re-engaged employee will terminate automatically on completion of 65 years of

age.

5. The Administration is at liberty to terminate the service of the re-engaged employees even before 30.06.2025 by giving 07 days notice.

6. The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review are not eligible for Re-engagement.

- 7. The re-engaged retired employees are not entitled for any other benefit or facilities except the monthly remuneration as per RBE No.59/2024.
  - i) The monthly remuneration for re-engaged retired employee is fixed as monthly remuneration determined by reducing basic pension from his/her last pay drawn at the time of retirement.
  - ii) No increment, DA & HRA shall be allowed during the term of contract.
  - iii) An appropriate and fixed amount of transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term. However, they may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
  - iv)Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service.
- 8. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- 9. Re-engagement shall be subject to prescribed medical fitness for the post.
- 10. Suitability / Competency of the applicant shall be adjudged before their re-engagement. They may be posted anywhere in AMJ/PNO/MLG/GHY/NGC area as per requirement. The Re-engaged retired employee will have to give 07 days' Notice for discontinuing the service.
- 11. Re-engaged employees shall be on duty as per requirements of the activity center. The duty hours can be changed as per the requirement of work by the administration. The willing retired staff should report for the "WALK-IN" interview to the office of the General Manager(P)/ HR Training centre, Maligaon, Guwahati-11 on 15.10.2024 at 10.00 hours, with copies of all certificates/testimonials in ORIGINAL and attested true copies of Service Certificate, Pensioner Identity Card & Pension Payment Order, Bank Pass Book (1st Page) Indicating A/C No., IFSC Code, PAN Card, Aadhar Card and also three passport size photographs. In event of any wrong information/fake academic certifications/testimonials etc. the candidates will liable to be taken up under Govt. of Indian's law, in force.
